

ALL IN ONE TERMS AND CONDITIONS

- 1. Participant's Fitness: Participants must be in good physical condition and capable of engaging in the activities offered by our company, including but not limited to the various programs and academies we provide. By participating, they acknowledge and accept any associated risks.
- 2. Medical Attention: In the event of any medical attention required during the classes or activities, our company will provide appropriate and necessary First Aid treatment.
- 3. Waiver of Liability: Our company shall not be held responsible for any claims, demands, suits, actions, or proceedings arising from bodily injury, death, or damage to property, except for cases of willful or negligent acts or omissions by our coaches or representatives as provided by law.
- 4. Damages: The participant or their parent/guardian shall bear the full cost of any damages caused by the participant or the parent/guardian during the classes or activities.
- 5. Language of Instruction: All classes will be conducted in English.
- 6. Conduct and Safety: Ensuring the safety and well-being of all participants is our top priority. Therefore, we reserve the right to remove any participant or parent/guardian who engages in bullying, misconduct, or disruptive behavior from our trainings/activities, without any refund for the remaining sessions.
- 7. Allocation of Spots: Places in our programs/activities are limited and will be allocated on a first-come, first-served basis.
- 8. Changes and Cancellations: All classes, activities, venues, and arrangements are subject to change due to weather conditions, programming needs, and participant numbers. We reserve the right to cancel courses or modify information if necessary. In cases of extreme weather conditions, we may cancel classes for the safety of participants and coaches. No refunds or



make-up sessions will be arranged for weather-related cancellations. Refunds for After School Activities will depend on the school policy.

- 9. Media Release: By participating, participants or their parent(s)/guardian(s) grant us the worldwide right, without approval or compensation, to use the participant's name, photographs, videos, or likeness for reasonable commercial purposes such as advertisements in newspapers, magazines, and online social media platforms (Facebook, Twitter, YouTube, Instagram, etc.).
- 10. Acceptance of Applicants: We reserve the right to refuse any applicants without giving reasons.
- 11. Dress Code: No participant will be permitted to attend our classes/activities without the official outfit or appropriate sports attire.
- 12. Confidentiality: Neither the parent(s)/guardian(s) nor the participant shall disclose or use any aspect of our course/program for commercial purposes.
- 13. Parental Consent: If the participant is a minor and you are not their parent or guardian, you confirm that you have made the parent or guardian fully aware of this booking, the terms and conditions, and that they have agreed to them.
- 14. Parental Communication: Parents or guardians are not allowed at the classes/activities and must refrain from talking to coaches during the training session. Any questions or concerns can be addressed to the head of the activity after the class/activity.
- 15. Participant Safety: Our responsibility for participants is limited to the duration of their activity/class. We are not responsible for participants outside or around the facility, before or after classes. The responsibility lies with their parent(s)/guardian(s) (applies to minor participants only).
- 16. Medical Conditions: If a participant has any medical condition or develops one during the membership duration, immediate notification should be provided to our Client Relations team.



- 17. Competitions: Competitions conducted by our company are subject to our discretion. In all matters and disputes, the decision of our judges and officials shall be final, and no correspondence or discussion shall be entered into.
- 18. Prizes: Any prizes offered are non-transferable, and there is no cash alternative. We reserve the right to substitute prizes of equal or greater value at any time.
